INTRODUCTION

All proposed orders should be submitted to the Court in Word format via CyberClerk with the exception of consent orders and consent judgment of forfeitures, which include a defendant's signature. A copy of the proposed document may also be attached to a referenced motion in PDF format and properly identified.

SUBMITTING A PROPOSED ORDER

To submit a proposed order using ECF, log into the system.

Click [CIVIL] or [CRIMINAL] on the blue menu bar at the top of the CM/ECF Screen.

Select [Submit Document to Court] under the CyberClerk category.
